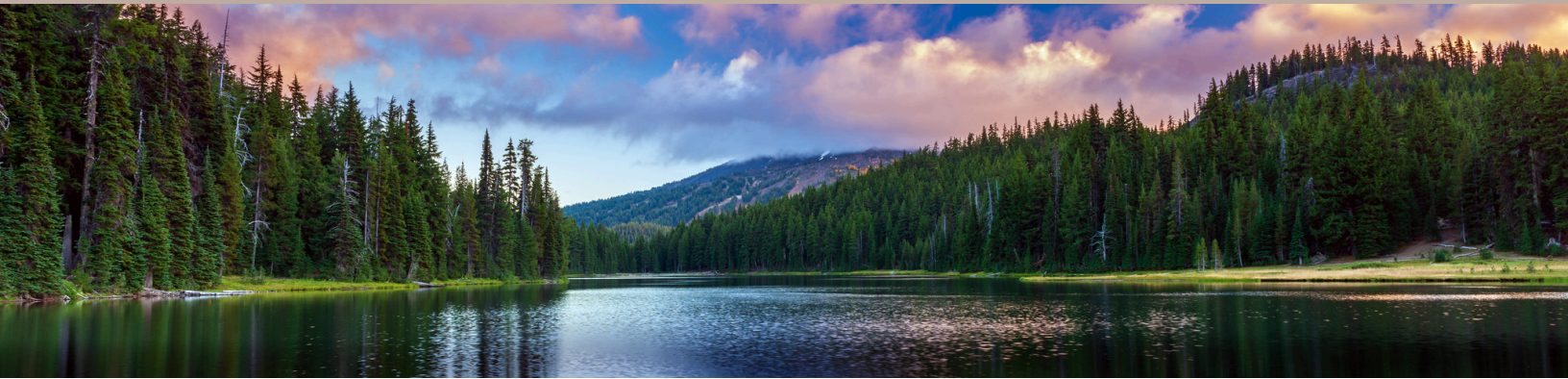

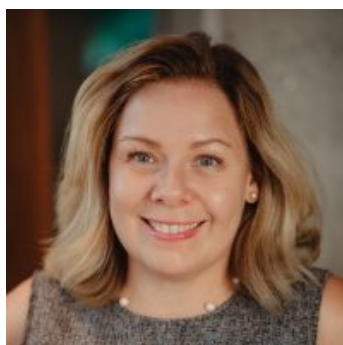


President's Message

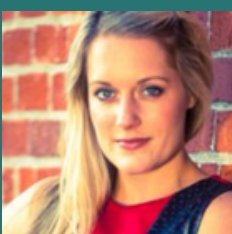

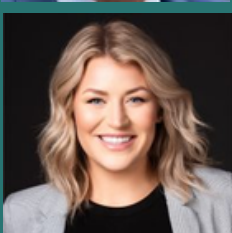

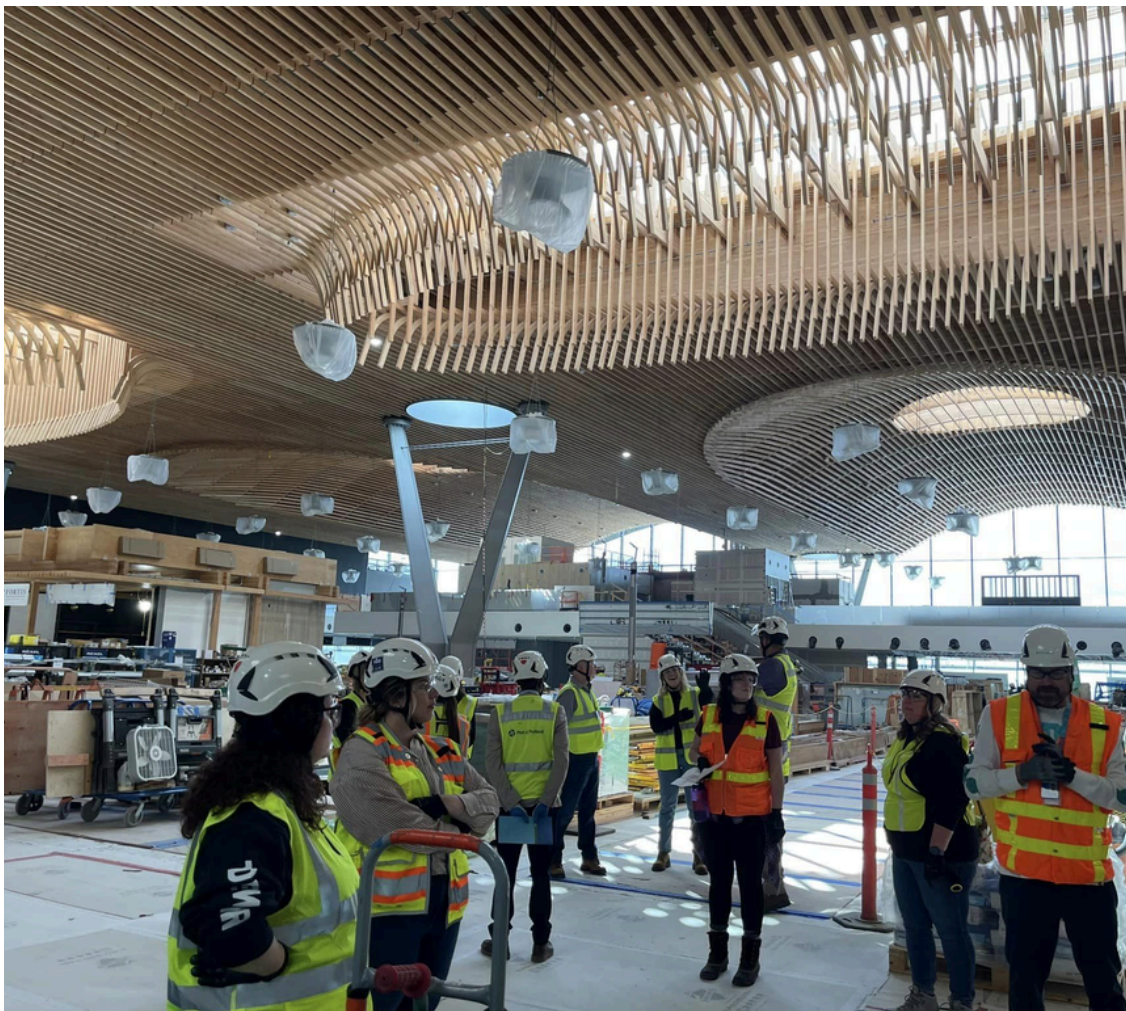
