
Dear Friends and Members of the Oregon Chapter RIMS,

Oregon RIMS Legislative Committee

On the heels of Oregon RIMS' 2 nd annual joint legislative event, another successful collaboration with Oregon PRIMA that saw a 33% attendance increase from 2023, I'd like to share some thoughts on what to anticipate from Oregon RIMS on the advocacy front for the upcoming year.

I'd like to first extend thanks to those who attended the December legislative event, helping us build on the momentum started last year with efforts to educate our membership in this area. Also, a special thank you to our panel who led this year's discussion: Sommer Tolleson (managing partner at Tolleson, Conratt and Replogle LLP), Ann Klein (President at Majoris Health Systems), and Kirsten Adams (Director & Comp.; Counsel of Policy and Public Affairs at Associated General Contractors).

Based on guidance from RIMS Global's General Counsel, there will be some administrative work on my part to firm up the Advocacy Ambassador position within our local chapter. This will involve possible by-law and/or policy language updates, to formalize how best to advocate for the legislative interests of our members, using a risk management-focused lens. It will also include updates to how the Oregon RIMS Legislative Committee is structured, to accomplish any advocacy-related goals that are set.

Once the administrative foundation is in place, our primary focus moving forward will be on helping mobilize Oregon RIMS members through education about legislative issues that will most likely have an impact, direct or indirect, on your organizations and employees. While the details are yet to be finalized, this may include a dedicated newsletter on legislative topics, notification of ways to get more involved both within your organization and with Legislative Committee efforts, as well as through formal positions taken by Oregon RIMS on various legislative concepts (i.e. in support of a balanced workers' compensation system).

Please feel free to reach out to me with any questions you might have, which you feel Oregon RIMS should be looking into on your behalf as members, and the employers that you collectively represent. I look forward to keeping you informed on the updates discussed above and wish you all the best in 2025!
